1. Scope of Work

Joburg City Theatres (JCT) hereby invites proposals from all prospective service providers to propose a cost effective solution for below mentioned. Service Providers are required to respond to this RFP (Request for Proposal) demonstrating that their proposed approach and solutions are a probable fit to JCT's requirements and are required to complete all categories as stipulated within this document.

All information contained in this RFP or given by management or staff of JCT is solely for the purpose of providing Service Providers with relevant information with which to complete and submit their proposals. The appointed service provider will be evaluated from time to time on the following basis: **Timeliness of service delivery; Quality of the service provided; Provision of services in compliance with clearly stated specifications;**

2. Specifications

The scope of work and/or deliverable must be as follows:

2.1. The purpose of the Request for Quotations is to appoint a service provider/supplier to Develop an Integrated Marketing, Communication and Sales Strategy for Joburg City Theatres (JCT).

- Design the integrated Marketing, Communication and Sales Strategy
- Assist in developing a JCT (three affiliates being Joburg Theatre, Soweto Theatre & Roodepoort Theatre) brand alignment strategy in positioning the brand within the respective markets
- Provide technical assistance and facilitation services in support of the strategic planning process
- Do desktop review and analysis of relevant documents to benchmark/ determine the planning trends in local government, industry, provincial and national government and identifying key strategic issues which the JCT needs to consider
- Conduct situational and research analysis for insight on the expectations in respect of the strategy, identifying the organizations strengths and weaknesses from an integrated marketing and communications perspective
- Align the strategy with JCT's organizational strategy, the City of Johannesburg communications strategy, and other entities that fall under the City of Johannesburg such City Power, Johannesburg Water and others
- Schedule a strategic planning workshop to unpack proposed draft
- Development of strategies and strategy implementation plans, including the operational plans
- The integrated marketing, communications and sales strategy must include the following key elements; marketing and communications strategy, social media strategy, sales strategy, website strategy and development, PR strategy, events strategy, media strategy and the stakeholder and inter-governmental strategy.
- The integrated strategy must be fully costed

2.2. Deliverables

The service provider will be expected to submit the following as deliverables on the above scope of work:

- Three-year integrated marketing, communication and sales strategy; operational and implementation plan
- Methodology
- Report
- Strategic Workshop
- Presentation by appointed supplier to JCT EXCO & Board as and when required
- Appointed supplier to share documents as follows:
 - First draft to be shared within 10 consecutive working days after awarding of contract
 - Workshop to be scheduled within 7 working days post submitting first draft
 - Second draft to be submitted 10 consecutive working days after workshop
 - Final draft strategy document and power point presentation must be submitted for EXCO review and approval by 31 March 2021

3. Competency, Skills & Knowledge

The service provider should have the necessary expertise, capacity and experience to deliver the services required. The company should have a dedicated team with the relevant work experience

4. Mandatory Administration Criteria

Joburg City Theatres reserves the right to disqualify any bidder which does any one or more of the following, and such disqualification may take place without prior notice to the offending bidder, however the bidder shall be notified in writing of such disqualification:

- a) Bidders must accept the Joburg City Theatres' Terms and Conditions of Tender;
- b) Bidders must produce a valid **Tax Clearance Certificate & Pin** issued by SARS
- c) Bidders must be registered on National Treasury's database (**CSD**)
- d) **NB: No bid will be awarded to any person whose tax matters have not been declared to be in order by the South African Revenue Services.**
- e) Minimum of three recent (not older than two years) contactable references from customers to which the bidder has provided or is providing goods/services that are **substantially similar to the goods/service required.**
- f) **Note:** Joint Venture references will only be accepted if the company is tendering as a JV

OTHER REQUIREMENTS

5. Notes to Pricing

7.1 Important: It is mandatory to indicate your total bid price as requested above.

7.2 The bidder shall quote rates both in figures and words. He shall also work out the amount for each item of work and shall write in both figures and words.

7.3 If any difference is found between the rates quoted by the bidder or in the amount worked out by him, the following procedure shall be followed:

- ❖ **When there is a difference between the rates on MBD 1 & the price section of this document, the rates, which correspond to the amounts worked out by the bidder, shall be taken as correct.**
- ❖ **When the bidder has not worked out the amount of an item, or it does not correspond with the rate written either in figures or in words, the rate quoted by the bidder on MBD1 shall be taken as correct.**
- ❖ **When the rate quoted by the bidder in figures and in words tallies but the amount is not worked out correctly the rate quoted by the bidder shall be taken as correct and not the amount.**

- 7.4 To facilitate like-for-like comparison bidders must submit pricing strictly in accordance with this pricing schedule and not utilize a different format. **Deviation from this pricing schedule could result in a bid being declared non-responsive.**
- 7.5 No claim for price escalation will be considered unless it is specifically stated that this RFQ is subject to adjustment. Failure to complete this clause will result in the RFQ prices being deemed to be firm.
- 7.6 Notwithstanding anything to the contrary contained in JCT's Conditions of RFQ, Memorandum of Agreement or the Price Schedule, any claim for an increase in the RFQ prices herein quoted shall be submitted in writing.
- 7.7 All tax invoices submitted by the Bidder must show the Value of the supply, the amount of tax charged and the consideration for the supply.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
