- **LOCAL PRODUCTION AND CONTENT:** Declaration Certificate for Local Production and Content for Designated Sectors as Annexure C and Local Declaration Summary Schedule must be completed and signed and only locally produced goods, services or works or locally manufactured goods, with a stipulated minimum threshold for local production and content will be considered. Tender offers will be declared non-responsive should they fail to comply with above requirement
- **EVALUATION CRITERIA** The 80/20 preference points system as prescribed in the Preferential Procurement Regulations, 2017 Pertaining to the Preferential Procurement Policy Framework Act, (ACT No 5 of 2000) (PPPFA) will be applied to evaluate all bids.
- Any bidder who arrives 15 minutes late for a compulsory briefing session will not be allowed to partake in the bidding process.

However, such submissions must comply with requirements as described therein, i.e. neatly bound and in its entirety with no pages omitted.
- Bidders are required to; together with their bids submit original and valid B-BBEE status level verification certificates to substantiate their B-BBEE rating claim. Those who do not submit their B-BBEE status level verification certificates do not qualify for preference points for B-BBEE but **will not be** disqualified from bidding process.
- **Telegraphic, telephonic, telex, facsimile and late bids will not be accepted.** All Bids must be submitted on the official forms (not to be retyped / re-arranged). Sealed documents, marked with the bid identification, must be submitted in the **TENDER BOX at Joburg Theatre Complex, reception desk - 1st Floor, 163 Civic Boulevard, Braamfontein between 08h00 and 17h00 Monday to Sunday on or BEFORE 12h00** on the closing date.
